EDGEPOINT SWPs – MONEY NOW, MONEY LATER

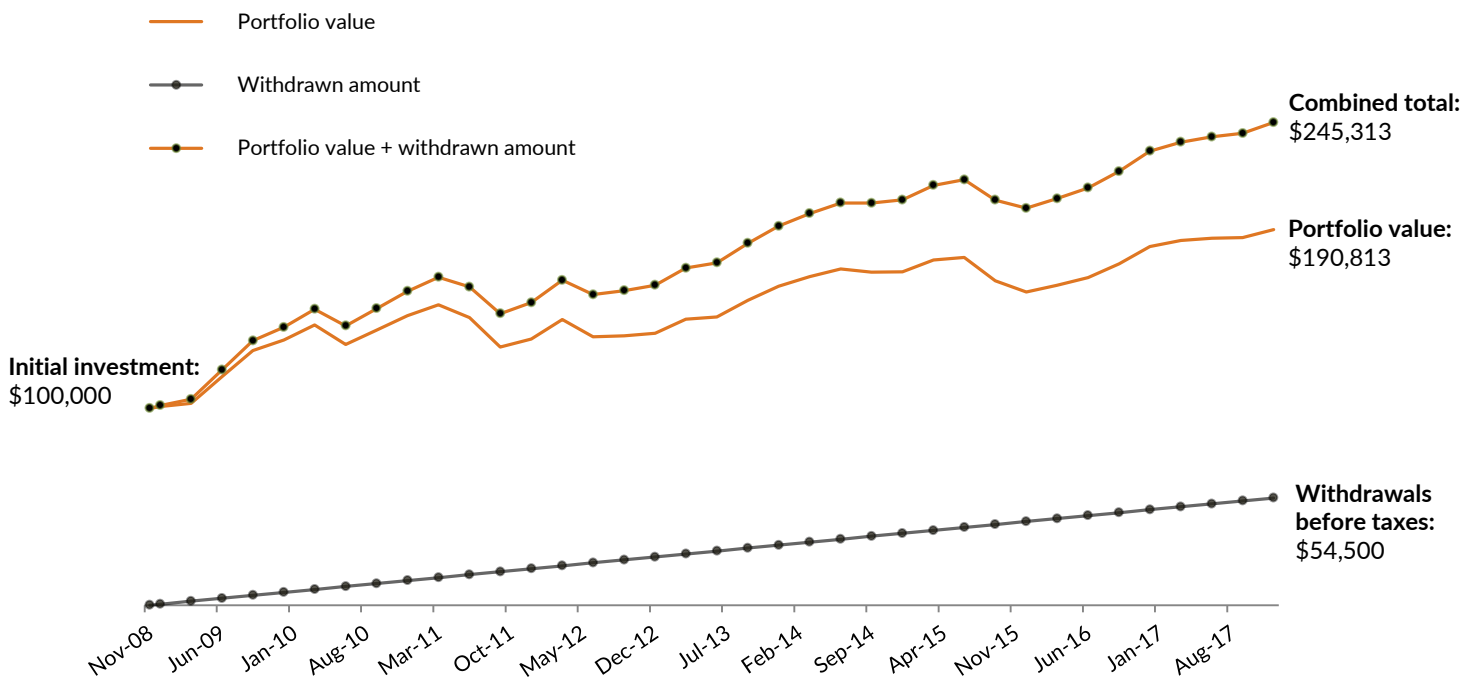
Inasmuch as investing is about delaying immediate gratification for future gain, done right a systematic withdrawal plan (SWP) can offer investors both. Very simply, a SWP lets you automatically take money out of your investment on a regular basis. If that investment is growing, a SWP provides a disciplined way to meet your income needs while you continue to build wealth.

Example: You invested \$100,000 on EdgePoint Canadian Growth & Income Portfolio's start date and immediately began redeeming \$500 per month. Annually, this represented 6% of your original \$100,000 investment. Distributions were reinvested.

Nine years later, on December 31, 2017, your investment was worth **\$190,813**. Your pre-tax withdrawals over that timeframe amounted to **\$54,500**.
